Paternal

Grand-Father: Gabriel Capone, died at a very old age, cause not known. Grand-Mother: Theresa Capone, Died at a very old age, cause not known.

Uncle: Name not known, killed while in active service with the Italian Army.

Grand-Father: Ralph Riola, dead, cause not known.

Grand-Mother: Theresa Riola, dead, cause not known.

SIBLINGS

Mother: Theresa Riola Capone, Age 68, living and in good health.

There was seven children in his mother's family, five boys, two girls. He states that his mother exchanges correspondence with her relatives in Italy, but he has no knowledge concerning the status of the family.

He states the family history is negative as to insanity, tuberculosisp cancer, suicide, syphilis and consenguinity.

The families, both paternal and maternal, were natives of Italy. He has been informed that they were engaged in the business of buying, selling and exporting Olive Oil. His father learned the barber profession, became self supporting and married at a very early age. Following the birth of the first child he with his wife and child emigrated to this country, entering at New York City. He become engaged in operating a combination pool room, bowling alley and barber shop, locating in Brooklyn, where with the exception of the first child, the other members of the family were born. He was naturalized and living in the State of New York at Brooklyn, when he died. Since the death of his father, his mother and all other members of the family have been living at his home in Chicago.

James: Left home twenty years ago to go West. He has not been

heard from since; if living he would be 40 years old.

Raplh: Age 37, health good, married, 1 child. Engaged in the

real estate business. He is at this time serving a three year sentence in the federal penitentiary at lavenworth,

for having violated the Income Tax Law.

Francis: Died as the result of gun shot wounds at the age of 32.

He was employed in the circulation and distribution department of a local newspaper, and injured while making

deliveries in a truck by some unknown person.

Alphonse: Age 33, prisoner.

Arminia: Died at birth, cause not known.

Mimi: Age 29, health good, single. Owner and manager of a garage,

in Chicago.

Albert: Age 28, health good, single. Associated with his brother

Mimi, in the garage business.

Mathew: Age 26, health good, married, 1 child. Engaged in the

security business at Chicago.

Mafalda: Age 24, health good, married, 1 child.

PERSONAL HISTORY

He is the fourth member of the family of nine. Born at Brooklyn, N. Y., January 18, 1899. Normal birth and childhood. He states that he has no knowledge of having had childhood diseases. Pneumonia at the age of 30. No other adult illness. He has three scars on the face, residuals of injuries recieved in a fight. Scar in groin, residual of bullet wound inflicted by an unknown person. No other injuries. Began school at the age of 7 attended regularly and reached sixth grade at 14. He states that he was interested in school and liked to attend. He took part in all usual activities at school, and was considered apt by his teachers, and relates of nothing out of the ordinary during childhood. He states that at the age of 12 he obtained work as a pin boy in a bowling alley, working during vacation and after school hours. At the age of 14, he was compelled to quit school to assist with the support of the family.

He obtained employment in the production department of the United Paper Box Co., manufacturers of fancy paper and leather boxes. He states this class of work requires considerable skill and beginers were paid seven dollars a week. He was promoted to higher position and was receiving twenty three dollars a week when he resigned after serving seven years with the one company. At the age of 22 he accepted a position as manager of a dance hall in New York City. Six month later he resigned to accept a similiar position at Chicago. Here be became engaged in various business enterprises, including real estate, newspapers, hotels, garages, and security. He states that he has accumulated considerable money, and claims Chicago as his residence. He states that he ran away and married at the age of 17, his boyhood sweethart. They had attended school together, and were working at the same factory when married. His wife was Mae Coughlin and 16 years of age when they married. There is one child, no miscarriges. Both wife and child are in good health and living at their home at Chicago. He contracted gonorrhea at the age of 24; treated and cured by a physician. In 1931 his blood Wasserman showed positive for which he was given several intramuscular, anti-lustic injections. He denies the use of drugs, admits the use of beer and wine. No military record. No compensation.

He states that his arrests have been to numerous to mention, useing as a criterion the fact that he was arrested eight different times in twenty four hours at Miami, Florida.
